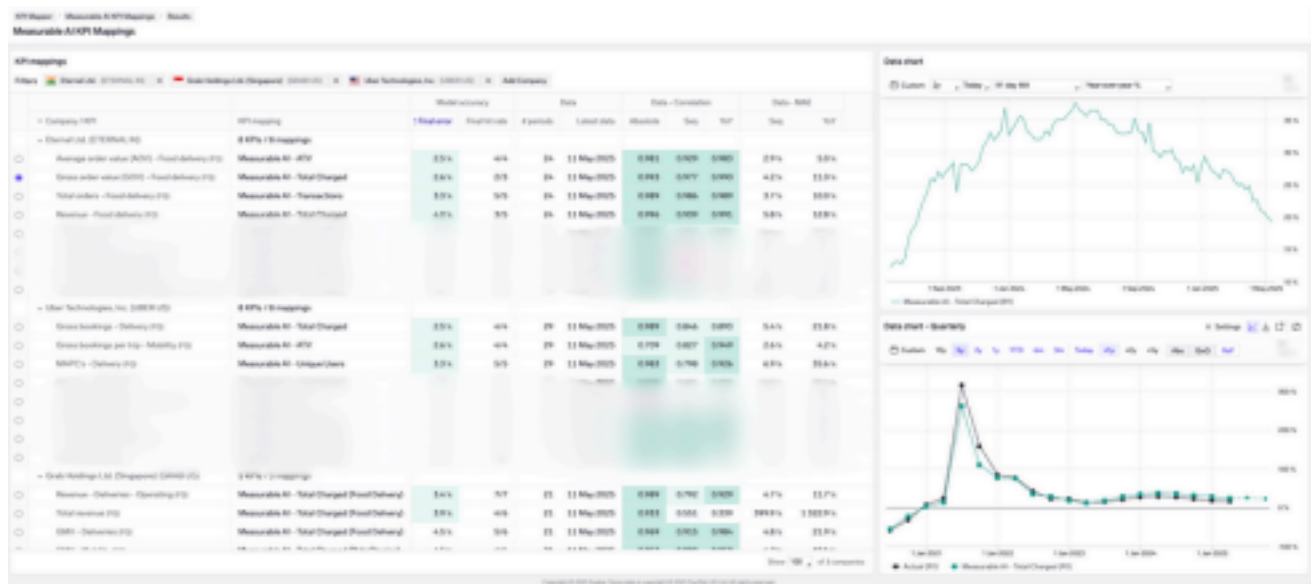
Performance

KPI Mapping Example



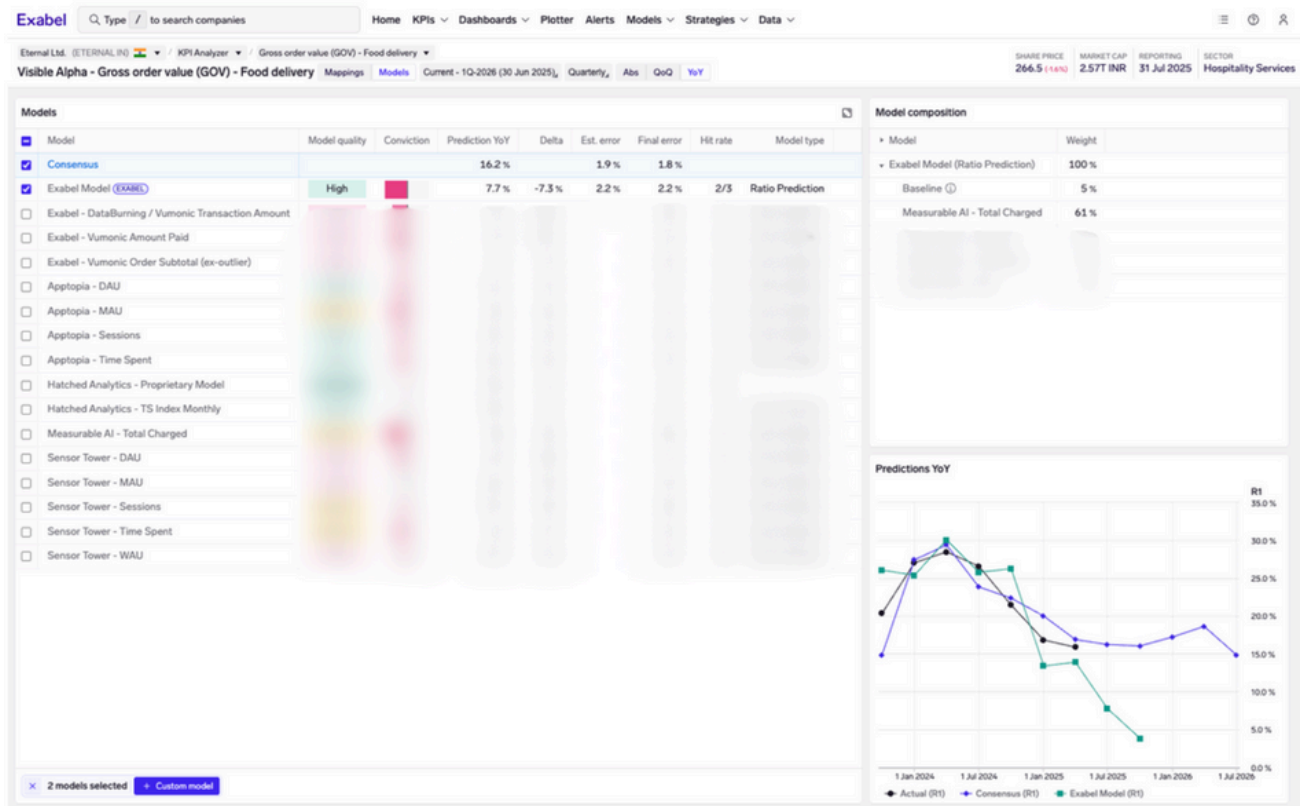
Tactical Use Case: Eternal Ltd.
